Section 7 - Handling and Storage

Note that one of the ingredients, Urea Ammonium Nitrate is known to be corrosive to some metals and makes some polymers brittle. Regularly check all vessels and pipe work that may be used in the storage and distribution of this product. Ziltek can provide further details on request.
